MARKET COMMENTARY

- The TSI surged massively by 21.26 points, driven by gains from TPCC, MBP, DSE, AFRIPRISE and NICO by 6.36%, 5.49%, 4.94%, 3.23% and 1.81%, despite a fall of 10%, 3.7%, 1.72% and 0.63% from PAL, DCB, MCB and MKCB.
- Meanwhile, the DSEI increased by 3.26 points despite a fall of 0.63% by JHL.
